- Delivered a self-serve account recovery journey with engineering, product, clinical, security and ops, cutting account-related tickets by 50% and clearing a 4-month backlog (100k+ accounts recovered in 4 months).
- Designed a settings entry path for partner-direct traffic (homepage bypass). I created a general, non-partner-specific pattern, highlighted risks, facilitated stakeholder discussions to align approaches, and ensured reuse across services.
- Led Welsh-language discovery: defined a single-codebase string-swap and context-aware toggle, set clinical and legal review workflow, and aided in developing a proposal to secure funding for POC.
- Championed a discovery to streamline help and support by auditing journeys and content across platforms, simplifying flows, identifying user needs and framing expectations for these journeys to reduce drop-offs and support demand.
- Built production-like HTML/ CSS/ JS prototypes; partnered with developers and QA to triage bugs and improve release quality, and supported other designers in the creation of complex prototype flows.
- Translated business needs into prioritized backlogs & acceptance criteria; maintained design history, decision logs and dependencies for auditability; championed WCAG 2.2 AA across delivery.
